Below are stories of just a few of those we are helping who have suffered due to the negligence of others:

Stephen Raynes and **Joe Traub** recently settled a medical malpractice lawsuit on behalf of their 77-year-old client who had to have part of all four of her extremities amputated during a hospital admission. Stephen, Joe and their R&L team, working with several medical experts, were prepared to prove to a jury that this tragic outcome was the result of improper care causing a lengthy delay in recognizing and treating the significant infection that necessitated the woman's admission. A combination of septic shock and the powerful drugs that were needed to treat her shock interfered with the blood flow to the woman's hands and feet, necessitating the amputations. Within days of the trial starting, an eightfigure settlement was reached that will allow this proud wife, mother and grandmother to secure the care and treatment she needs and allow her to live the rest of her life with dignity while enjoying time with her family.

Tim Lawn and *Regina Foley* recently settled claims on behalf of a 45-year-old woman who suffered a brain injury while undergoing a routine, brief gynecologic surgery. The client had previously consulted with another, well known Philadelphia law firm, who told her she "had no case." However, Tim, Regina and their team refused to accept that this terrible outcome was acceptable. Working with medical experts from as far away as California, Tim and Regina were prepared to prove that the client suffered these injuries because of a delayed response by the anesthesia team to certain monitor findings suggesting that the patient was having difficulty oxygenating her blood. The multi-million dollar settlement will improve the quality of the client's life while getting the care and services she needs.

Noah Goodman led our firm's representation of a pre-school teacher who was racially profiled as she shopped at a retail store. During the incident, the retail store manager falsely accused our client of theft and called 911 to report her -- not because she had stolen anything but rather, because she assumed that our client must be a thief because she is Black. Despite having a receipt proving her purchase of all the items she had bought, our client was detained and subjected to two searches by the police. In February 2023, our firm filed a lawsuit against the retail store asserting claims for negligence, negligent training and supervision, and violation of the Pennsylvania Human Relations Act. After extensive discovery and the litigation of several significant motions, Mr. Goodman was able to successfully obtain a confidential settlement on behalf of our client.

Stephen Raynes and **Joe Traub** recently settled claims brought by a woman who was struck on her head when the ceiling fell down on her while she was doing laundry in the shared laundry room of the 250-unit apartment building where she lived. The drywall ceiling detached from the structural concrete without warning and struck her on the head. The building managers knew about a leak from an AC unit several floors above the laundry room, and had taken measures to fix the leak, but had not investigated its possible impact on the laundry room ceiling, which had been improperly installed. The brain injury was not detectible on imaging studies, yet she suffered ongoing symptoms including photophobia, phonophobia, forgetfulness, and loss of balance. The case resolved shortly before trial was scheduled to begin.

Stephen Raynes and **Joe Traub** recently settled a lawsuit filed on behalf of the wife and children of a 37-year-old man who died in a hospital due to a gastrointestinal perforation. Stephen, Joe and team were prepared to prove that the hospital staff failed to promptly recognize and surgically repair this perforation, resulting in his death. After a jury was selected and as trial testimony was about to start, a significant confidential settlement was achieved.
