## Tim Lawn Becomes President of PTLA

Tim Lawn has been installed as the 2018-2019 president of the Philadelphia Trial Lawyers Association (PTLA). He was passed the gavel at the association's annual meeting at the Sofitel Hotel before 170 PTLA members. His presidential term began July 1, 2018.

Known for his unyielding commitment to his clients, Lawn has devoted over two decades to the representation of those who have suffered serious injuries or death because of the negligent acts of others.

In addition to having held several leadership positions in the legal profession, Lawn also serves as chair of the Dave Palmer Memorial Foundation, a charity he founded in 1992 to provide financial assistance to children who have lost a parent to an untimely death. He is also a member of the board of directors of Frankie's World Foundation, a daycare provider for children with medical needs in North Philadelphia.

As someone who spent years teaching trial advocacy to law students and who commits countless hours teaching other attorneys in continuing legal education seminars, Lawn stated that one of his main goals this year will be to focus on training the next generation of trial attorneys and future PTLA leaders.



## Tim Lawn Inducted into IATL

On July 21, 2018, Tim Lawn was inducted as a fellow of the International Academy of Trial Lawyers (IATL). IATL is an international group of elite trial lawyers from more than 30 countries who have demonstrated exceptional skill and ability in jury trials and appellate practice throughout their career.
