

Client Story:

Two years ago, four members of Yeadon Borough Council fired Police Chief Anthony Paparo. Their motive was racial: they wanted a black Chief to lead the department and Paparo is white. No matter that Chief Paparo had reduced crime, developed police community programs and activities, and made Yeadon a safe place in which to live and work. No matter that Chief Paparo was a beloved member of the Yeadon community. The only way the four Council members could achieve their goal was to act as judge, jury and prosecutor. And so, on February 17, 2022, they fired Chief Paparo. Not content with that result, they spent much of the succeeding two years publicly maligning Chief Paparo, a campaign that rendered him unemployable and tarnished his 30 plus-year career and reputation as a highly respected law enforcement officer.

Our firm took on Chief Paparo's case in court with the kind of tenacious advocacy that stood in sharp contrast to the defendants' belligerence. After months of discovery, Judge Baylson, the federal Judge assigned the case, denied the defendants' motions for summary judgment and greenlighted the case for trial. As trial loomed, the defendants agreed to a settlement. It was for \$2.5 million.

To the lawyers who spent the last two years representing Chief Paparo - Harold I. Goodman and Noah J. Goodman - and their staff - Mark Merlino and Regina McDonough - our thanks and congratulations for a job well done.
